**GOOD EVENING.** At 7:00 PM Central (Daylight) [Standard] Time, this is the Weekly GMRS Radio Net of the North Shore Emergency Association. This Net is conducted every Sunday evening at 7:00 P.M, Primary purposes of this net are:

- To maintain weekly contact with members and affiliates of NSEA;
- To ensure radio equipment and system operation are maintained in case of Emergency;
- To maintain proficiency in net procedure;
- To announce items of information between meetings; and
- To serve as a method to unite associate groups, and other GMRS operators for: public service, emergency and disaster communications. **[BREAK]**

Net Control (will) [will not] be simulcasting this net on GMRS channels .675, .650, and .700 tonight. [We will take check ins on .675 first. After the role is called on .675, we will then take check-ins on .650 and .700. Traffic will be conducted on .675.]. **[BREAK]**

When we begin the Rollcall, please check in with only 1 ID. State:

- Your unit number, ID or call sign;
- Your radio type (mobile, portable, control);
- Your Location;
- Whether or not you have traffic; and
- Conclude with your F.C.C. call sign, if not already transmitted. [BREAK]

Rollcall will be made by affiliation level, not necessarily in numerical order. After the regular roll is called, we will take any first time or late check-ins, then traffic from checked in units, and lastly announce Standing Traffic. [BREAK]

Two polls will be conducted during this net. If you have not already submitted answers, please do so now when checking in. First Poll is: Have you received interference from Indiana?
